The Urban Arts program of the Winston-Salem Arts Council has awarded \$1,000 to the West End Association to be used to secure the design and construction of sculpture in Hanes Park. It is contemplated that the sculpture will not be something to look at only, but will be something which will attract all of us to participate with--to react to the sculpture and with its art and design.

Lida's committee is currently in the process of seeking design suggestions from artists, and will report to the Board from time to time about progress. Residents interested in this project are encouraged to make their interest known to Lida.

## RECENT ACTIVITIES OF THE WEST END BOARD OF DIRECTORS

Since the last general meeting of the Association in May, at which a new board and officers were elected, the Board has met monthly to discuss a variety of topics. Everything from immediate issues such as the proposed

Reynolds High School parking lot on Reynolda Road (this is now a dead issue, at least until the summer of 1977) to the long-range needs of the neighborhood as might be expressed through the land use survey have been discussed.

We are in the process of having a draft constitution and by-laws considered and then brought before the Association for comment and possible adoption. This would enable us to become a non-profit corporation, and possibly become tax deductible.

We have received a grant from the Arts Council for a sculpture in Hanes Park, have discussed and negotiated with Holladay Supply Company concerning the old Jenkins property on West Fourth Street (now torn down), have rejected a proposal by the Top and Trim Shop on Burke Street that a vacant lot on West Fourth Street be used as a parking lot, have heard preliminary plans for a low-density housing development for the elderly on Sunset Street, and have passed a unanimous resolution supporting the exchange of the Carolina Theatre by the newspaper, giving the city a downtown theatre which would become a performance center for the North Carolina School of the Arts.

Additionally, of course, we have continued to consider the housekeeping matters which attend the business of the Association, and, through committees, we have planned and executed the recent successful covered dish supper at the YWCA.

The Board, in an attempt to get all around the neighborhood, and to establish good relations with the institutions in the West End, has met at the YMCA, the YWCA and the Winston-Salem Women's Club. We thank these fine organizations for their hospitality.
