### COMMUNITY DEVELOPMENT FUNDS FOR "WEST END: SOUTH"

"West End South," which is the area of the West End south of First Street and bordered by I-40 and the alley behind Fourth Street on the east side, has been tentatively approved as a Community Development Project Area and is expected to start receiving Community Development funds for 3% interest rehabilitation loans and other neighborhood needs beginning in July of this year.

The designation was made by the Board of Aldermen at a six-hour meeting on Saturday, January 7, 1978, with the Community Development Management Team, which has had the task of investigating and evaluating the needs of several neighborhoods of Winston-Salem and which recommended West End South as a new Community Development Project Area.

Final approval and submission of the appropriate applications to HTD will take place after the public hearing which is scheduled for February 6, 1978, at 7:30 p.m., at City Hall, so it is important that we sustain our effort and support for Community Development funds for this section of the West End.

A West End South neighborhood meeting has been scheduled for 3:00 p.m., Sunday, January 22, 1978, in the home of Paul and Claudia Shepard at 1406 Jarvis Street in order to discuss the Community Development Program. For further information, please contact Paul Shepard at 722-8253.

#### TREASURER'S REPORT

For this newsletter, suffice it to say that in 1977 we took in \$3,596.53, and obligated a total of \$3,730.08, leaving a deficit of \$133.55. It should be pointed out that we currently have over \$2,100.00 in our bank accounts, because 1977 obligations remain to be paid, principally on the sculpture project. At any rate, we will need to raise money during 1978, and your membership renewal at this time would be appropriate.

## WEST END SOUTH NEWSLETTER


You are invited to a neighborhood meeting at 3:00 o'clock, p.m. next Sunday, January 22, 1978, at the home of Paul and Claudia Shepard, 1406 Jarvis Street, Winston Salem, N. C., at which we residents of the West End South (the area marked on the attached map) will discuss several matters crucial to our future.

The Board of Aldermen has tentatively approved the West End South as a Community Development project area, as recommended by the city staff after a thorough study. Funds for the neighborhood are expected to be available beginning this July. Harry Weiler of the Planning Department will be on hand to explain the program (which includes 3%-interest loans for home rehabilitation) and to answer questions.

It is most important that we sustain our effort and support for community development funds for this neighborhood, because final approval of the project areas will not be given until after a public hearing February 6, 1978 at 7:30 p.m. in City Hall.
