BOARD OF DIRECTORS MEETING

Your West End Board met at the home of Glen and Joyce Gravlee on April 13. Thirteen officers and board members attended.

Alderman Martha Woods attended the meeting at our request to discuss concerns about zoning regulations and processes. Among the many issues we discussed were:

- Lack of information provided to property owners about plans that affect them
 - Waivers given to developers of properties that do not conform to provisions of the zoning law
 - Off street parking for apartments
 - Cooperation with the Inspections Department

Ms. Woods assured us of her support and concern for property owners in the West End (as part of the Ward). She stated that this was part of her campaign platform.

Ms. Woods had no specific response, however, to specific cases cited where it appears that present zoning laws have been interpreted to favor the interests of certain developers versus the long rang city planning guide and local residents.

We approved the appointment of a committee to study the present zoning regulations and recommended changes. These will come to the Board and then be referred to the Board of Alderman. If you have input or questions, contact Ben Wilson, Glen Gravlee, or Rence Callahan. We also passed a resolution to be sent to the Alderman which suggest ways of better communicating zoning information to property owners and neighborhood associations.

The treasury has been bolstered by additional funds for completing Grace Court Park plans. Construction of the wall in the Park has also started.

The Board will meet next month at the home of Bill and Becky Gibson, Brookstown Avenue, on May 11, at 8:00 p.m.
