IS THE WEST END A SPECIAL HISTORIC DISTRICT?

Picking up where they left off several months ago, your Board and Officers have been since the holidays working to develop a plan which would put the Greater West End (i.e., West End and 6 rystal Towers) on the map as a historic preservation district.

As you recall from your newsletter last February, the National Register of Historic Places is a list of distinction indentifying for the people those properties worthy of preservation for their historic value to local, state or national interest. Nominations can include buildings, structures, objects, sites, or, as is our concern, districts. Listing on the Register is generally considered to be an honor. It can lead to protection against undesirable redevelopment projects, while encouraging through tax incentives development of income-producing properties by certified rehabilitation of existing structures. It probably helps increase clout in City Hall.....Continued to page 2 . . .
