## HISTORIC DISTRICT

The May meeting drew an especially small crowd but we heard a number of reports of progress toward achieving National Historic District status for West End. It's going to take some time (probably eighteen months to two years) and some money (on the order of \$20,000), but the rewards seem to justify both.

There is not room to publish the whole plan and its requirements and advantages in any one issue of the newsletter, so we will take it one bite at a time.

### What Is The National Register of Historic Places?

The National Register is a list of properties worthy of preservation for their historic value. It is authorized by the Historic Preservation Act of 1966. Nominations can include buildings, structures, objects, sites or districts. Nominations are made by the State Historic Preservation Officer, after approval by the State Professional Review Committee and the Survey and Planning Branch, Division of Archives and History. Nominations are sent to the National Register, Heritage Conservation and Recreation Service, in Washington, D. C. They are reviewed there, and then, if approved, entered in the Register.

### What Does Listing In The National Register Mean?

First, it is recognition of the importance of the property or district to the past and present of the locality, state and nation.

Second, National Register listing means that, according to state and federal law, any state-funded or assisted project, or any federally funded, licensed, or assisted project that might have any effect (positive or adverse) upon the integrity of the National Register property or district must be reviewed according to certain procedures. Generally, this means that the State or Federal official must contact the State Historic Preservation Officer to assess the effect of the project on the National Register property, and the necessary review procedures are then followed. This could include, for example, a Federal highway going through a house; an urban renewal project destroying part or all of a historic district. The review does not always mean that the historic property is saved, but in many cases it does.

A very large majority of these businesses support the West End Association with their commercial advertising or family memberships. It is appropriate that West Enders return that support with their patronage.

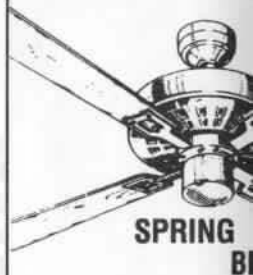
COMMUNITY WATCH

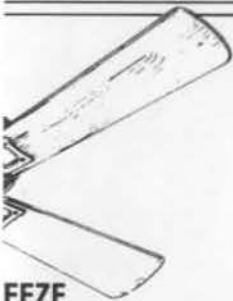
