But, I have a confession to make (Father). These house tours are really enjoyable and interesting, the way the West End puts them on. And I'm not putting you on.





Well, it did convene on November 5th, and folks discussed <u>The</u> <u>Holiday House Tour</u>, with committee reports about getting food, hosts, clean-up, transportation, publicity, etc. The most brilliant decision was NOT to sell poinsettias this year (they are in short supply and cost a ton) or box lunches (they were in excess supply last year, even though they didn't cost a ton).

We talked about traffic problems at the 5-point intersection near where the Christmas Party is going to be. These included congestion along fourth street from people parking on both sides of the street, speeders violating the law and endangering everyone in sight along lst, and large busses. A letter is being sent to the Police Department asking it to enforce the existing laws more closely. And a suggestion from Neighborhood Watch: if you see the same car chronically violating the speed laws, call the police and give them the license number and a description of the car. Another thing, if you see little kids playing in or too near the street, stride up to them in a menacing fashion and threaten to beat them up if they don't quickly retreat to a safer location. They'll be terrified, of course, but when they have kids of their own, they'll love you for it.

There was some concern, still, over the lack of a landscaping plan from the YMCA, as promised by the Zoning Board's ruling. Attention is being paid.
