The annual neighbrhood meeting was well-attended on February 4, but for those of you who were down with the ubiquitous flu or home watching the Carolina game on TV, here's a report.

In addition, Gwynne Taylor and Laura Philllips gave a report on their progress researching the history of the West End for the Historic District Application. They are still asking us for any historic tidbits we may have...maps, photos, deeds, gossip or whatever...that may give clues to the neighborhood's past. Wake Forest has loaned us a senior art major as an intern to help on this project.

The members present voted to continue to oppose any conversion of R2 zoned property to R1 in a continuing attempt to maintain the residential character of the area. Also, the Association will continue to oppose the construction of the Reynolds High stadium based on a consensus of this meeting.

Another matter was discussed and resolved at the Zoning Board meeting on February 6. Griffis and Hollingsworth Advertising had requsted a variance to waive a parking requirement and reportedly to add a lot in front of their new building on the corner of Fifth and Summit. The Association agreed to support the request for a five-parking-space waiver subject to their approval of a new site plan positioning the proposed parking lot in a location deemed more compatible with the neighborhood. This was a very amicable agreement reached right before the Zoning Board met.





Do You Love Football?

Responding to the objections to the families whose homes would be most directly affected by the construction of a football stadium for Reynolds High School, the Board of Education decided in February not to build the athletic facility on Reynolda Road across from the Children's Home property. But, pressure to provide Reynolds with its "own" stadium is continuing. Search for an alternative site is underway. The school board has taken steps to give Reynolds some relief in two areas: First, the board agreed to a subsidy that would defray some of the expense of playing at the City's Bowman Gray Stadium. Second, the board approved a plan whereby Reynolds would be permitted to play soccer at Dalton School instead of Ardmore. Both these measures are temporary. The most likely spot for a Reynolds outdoor athletic facility continues to be Hanes Park, as dutifully pointed out by your "West Ender" several months ago. It is adjacent to the Reynolds gymnasium (and the locker rooms in it). More than likely, the school board (i.e. taxpayers) would not have to come up with new dollars to buy the land. Some kind of trade could be worked out. This is the only way a stadium can be built in a high-density area for under two million dollars. They must get the land for "free' or something close to it. How many of you think the taxpayers are going to fork over \$200,000 an acre for a football field in the middle of town? That is what Petree, Stockton and Robinson had to pay for the Child Guidance Clinic property on Glade Street. If you don't like the idea of a football stadium in Hanes Park, you had better start doing something to discourage it ...
