Bill Sugg issued a reminder that board members are subject to dismissal for more than two unexcused absences.

There was no Secretary's report, but minutes from the May meeting were distributed and approved.

Committee Reports

Christmas House Tour

Lea Loftis announced to "oohs and aahs" that Vestal Apartments is on the tour. eight homes and two businesses have committed. We need volunteers! Please call Lea. David Christenbury and Alan Johnson will run the door decorating contest.

Social Committee

Missie Vaughan reported that the Fourth of July is set. The band will play on Bill Sugg and Carol Wells' porch. Food will be located at Sue Apartments, 1101 W. Fourth St.

Hanes Park Task Force

Bill Stewart called a meeting of city people working with the task force. After the meeting, the city wrote a letter to Nancy Pleasants withdrawing from further participation with the task force.

The city has no further plans to improve or expand efforts in hanes Park. The city also withdrew funding for the proposed study.

The city will stay out of the parking issue at the Y.M.C.A. City officials encourage the Association to deal directly with the Y.M.C.A.

Ben Wilson commended Rence Callahan and the Task Force for a good job on a difficult task.

Y.M.C.A. Plans

Ben Wilson recently learned that the Central Y.M.C.A. has plans for expansion of its present facilities. The plans include a parking deck, an addition (upward) for an aerobics room and expansion to allow consolidation of entrances. Money, other Y.M.C.A. facilities and the City Inspections Department are the three major thresholds that the Y.M.C.A. must overcome in order to succeed with its expansion plans.

Ben noted existing tensions between the West End Association and the Y.M.C.A. Lea Loftis proposed that the Association draft a letter at the earliest possible date to the appropriate people on the Metro Y Board and at the Central Y allaying fears that the Association is totally anti-Y.M.C.A. The board approved such a letter to demonstrate a spirit of cooperation.

Historic District

Chris Chapman discussed the Y.M.C.A.'s reluctance to be part of the Local Historic District and its desire to exclude Hanes Park from the district. The state historic district staff has written the Historic District Task Force a letter stating that it is unacceptable to exclude either Hanes Park or the Y.M.C.A. from the local historic district.

The Historic District Task Force is in favor of expanding, rather than contracting, the National Registry Historic District boundaries.

Chris next discussed the June 6th meeting on the local historic district. He passed around copies of the Design Summary.

Chris discussed his general impressions of the reasons that some people are averse to the local historic district. Some feel that the Association will control the district. Not true. The Historic District Commission has control based solely on the Design Guidelines.

Lea Loftis proposed writing letters to all major non-contributing building owners soliciting support of the local district.

Glenn Eisenbrandt proposed a neighborhood petition demonstrating support for the local historic district effort.

Membership

Lannie Eisenbrandt proposed publishing a membership roster to circulate to members. The board approved with the caveat that the list is not to be used as a commercial mailing list.

New Business

Bill Sugg reported that Rence Callahan has applied for a setback variance in order to add an enclosed stairwell to reach bedrooms to be added in his attic. The Setback will be the same as the existing house. The board voted unanimously to support the application.

Ira Tidwell (Senior V.P. at Wachovia) called Bill and discussed modifications to the Sears building. The old tire center has been razed and a new structure housing three diesel generators will be erected. The generators are to be used as an uninterruptible power supply for Wachovia's computer center. Benefit to West End: No more brownouts!

Barbara Garrison has requested our forbearance and approval to allow a one or two bedroom bed and breakfast at 927 W. Fifth Street. Parking will be in the rear. The board voted and unanimously approved to support the requested variance.

Bill Wise updated us on the "progress" of the new zoning ordinances.

The board thanks Bill and Dottie Wise for leading the German exchange students on a tour of the West End. H.L. Shaw from the school system called to extend his thanks. Meeting adjourned at 9:53 p.m.

LOCAL HISTORIC DISTRICT INFORMATIONAL MEETING HELD

On June 6, 1990 an informational meeting was held at the Y.W.C.A. Approximately 75 people attended the meeting, which was presided over by Chris Chapman. LeAnn Pegram of the City/County Planning Staff and Larry Robbs, chairman of the local Historic District Commis-

sion also made presentations at the meeting.

Chris summarized details of the national filing and then passed out a pictorial design summary that was put together by the Historic District Task Force and City/County Planning staff.

LeAnn summarized the pictorial design summary and explained how the written design guidelines are used in conjunction with the pictorial summary.

Larry Robbs explained the composition of the Local Historic District Commission and the procedures involved in applying to the Commission for approval of projects.

The Historic District Commission currently consists of five people. If the West End achieves local historic district status, the Commission will expand to nine positions. The Commission must consist of one resident from each historic district (Old Salem, Bethabara and West End), one atlarge resident (of any of the historic districts) member, one licensed architect, one business person, one lawyer, one architectural historian and one at-large member. Members are appointed for three year terms, with a maximum of two terms.

The first step in seeking Commission approval includes filing for the certificate of appropriateness (if required). The Historic District Commission meets monthly to review applications. The City /County Planning staff reviews the application and makes a presentation and recommendation at the monthly meeting. The monthly meeting, which is open to the public also includes a slide review of the proposal, a requestor presentation, an opportunity for opposition to speak, discussion of the proposal, and a board vote. Appeals from Commission denials go to the Board of Adjustment and then to Superior Court.

Three or four public informational meetings are scheduled for the future. Dates are not yet set.
