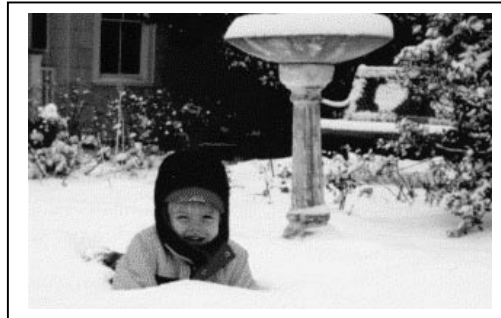

South Central Area Plan. The January 24 meeting of the citizens' advisory committee reviewed vision statements previously drafted by small groups, and added opportunities and obstacles to the extensive lists formed at the earlier neighborhood brainstorming sessions. Among suggestions from the West End small group (Price Davis, Eric Elliott and myself) were dealing with on/off street parking issues, attracting upscale retail food/entertainment and developing a greenway along Business 40. Also at this meeting the committee was given a packet including data and planning staff observations representing the existing conditions in the South Central area. If you have a concrete idea for a new guideline, new method of revitalizing our area, new thoughts on recruiting business to Burke, specific plans on preventing property speculation, etc. please let me know. Please note concerning greenway trail at end of Jarvis Street/Hawthorne Curve: the major private property owner along the potential greenway trail, Bertha Copley, has indicated her support for the greenway.
