Hanes Park Centennial Celebration & Ribbon Cutting!

After almost five years of planning and work, Phase One of the Hanes Park Repair and Renovation project is nearing completion. Plans are now being made for Phase Two of the project. The project is funded by the bonds approved by Winston-Salem voters in 2014 with supplemental funding from the City. The plan was designed by MLA Design Group, Inc., of Winston-Salem. Work continues on the southwest corner of the park near the intersection of North Hawthorne Road and Glade Street. The near completion of these renovations coincides with the 100 year anniversary of the creation of Hanes Park. The city will celebrate the centennial and the beautiful park renovations with a fun, festive day on the first Saturday after Labor Day.

The Opening Ceremony declaring it Hanes Park Day will begin at Promptly at 11:00 AM at the tennis center in the track area.

West End Historic Overlay Design Guidelines Update

The office of the Historic Resources Commission continues to work on revising and updating the Historic Overlay Guidelines. After a series of public meetings in July and August, the staff is working to incorporate input into the revised Guidelines. Mildred Borden & Robert March Hanes Houses

1219 Forsyth Street (ca. 1915) & 140 North Stratford Road (1926-27)

When Robert Hanes returned home from World War I with his new wife, Mildred Borden of Goldsboro, they lived in this two-story Colonial Revival house on Forsyth Street. Both from prominent families, they had married in July 1917 in an evening wedding in Goldsboro, with music at the reception provided by the Meyer-Davis Orchestra of Washington, D. C. That September, the new Mrs. Hanes shared an apartment at Georgia's Camp Oglethorpe with three other North Carolina brides whose husbands were in officer training there. Hanes served in France from 1917 to 1919, attaining the rank of major, and after the war, they lived in Europe for two years while he served the government. The Haneses were the second occupants of the Forsyth Street house, which they purchased in 1919—and where they lived from 1921 to 1926 and their children Frank and Sarah were born.

Robert Hanes was the fourth son of textile pioneer John Wesley and Anna Hodgkin Hanes's 6 boys and 2 girls. His widowed mother and some of his siblings lived around the corner on West Fourth Street in the Hanes mansion, Westerleigh (where Kilpatrick Townsend law offices are now located). A 1912 UNC-CH honors graduate and member of the first class of Harvard University's School of Business Administration, Hanes entered business (ice and rubber) with his brothers but soon began a career at Wachovia Bank & Trust Company. He worked closely with President (Colonel) Francis H. Fries, whom he replaced when Fries died in 1931. Hanes was lauded as a shrewd banker who guided the bank through the Great Depression. He was offered the presidency of the country's largest bank, Chase Manhattan Bank, and the New York Stock Exchange, which he declined. A Democrat, he served in both the North Carolina House and Senate and played key roles in the postwar Marshall Plan and the Research Triangle development.

A graduate of St. Mary's in Raleigh and Gunston Hall in Washington D. C., Mildred Hanes was a "formidable malapropist"—"Lord, make us needful of the minds of others"—who coined a mother-in-law's prayer: "Help me, God, to try not to be helpful."

Around 1926, the Robert Haneses moved to a Georgian Revival mansion on Stratford Road, where they resided the rest of their lives. They lived alongside Robert's sister Lucy and his brother Fred in sumptuous estates designed by Reynolda's architect Charles Barton Keen (and his partner, William Roy Wallace) and landscape architect Thomas W. Sears.
