Neighbors, Police Address Crime Concerns in West End Safety Meeting

A West End neighborhood safety meeting was held on Monday, February 24th, 2020 thanks to a joint effort by the Winston-Salem City Councilman, Jeff McIntosh, the Winston-Salem Police Department, and the West End Association. This meeting was open to the public and was attended by Winston-Salem District 1 Police Captain Richard Newnum and Winston-Salem District 3 Police Captain Christopher Lowder. The purpose of this meeting was to bring neighbors up to date on crime statistics in Winston-Salem, share crime prevention tips, and to hear from neighbors about their current concerns regarding crime in the West End.

The Police Captains shared that:

- overall crime was down and their resources were up from this time last year, but resources were still limited.
- the citywide number of vehicle break-ins was down nine incidents compared to this time last year, but the number of home break-ins was up nine incidents.
- making sure your car is locked and that valuables were secured and out of sight are important steps to deter vehicle break-ins and theft.
- because this is a busy downtown neighborhood with lots of foot traffic, we should be on the lookout and call to report any incidents of suspicious activity displayed by pedestrians (suspicious activity includes trying car door handles, looking in car and house windows, and hanging around property where you know the person in question does not reside).
- they would try to increase patrol presence of marked cars and foot patrols throughout the neighborhood and concentrating on suspicious activity, particularly around Hanes Park.

- if we notice suspicious activity, we should call 9-1-1. If you are not sure a crime is being committed, then call the WSPD non-emergency number at 336-773-7700.

- If you notice truancy, call Reynolds High School directly and ask to speak with their school resource officer.

Overall, the statement of the police captains that they would increase presence in the neighborhood to the best of their ability was met with a positive response from the residents in attendance.

The West End Association and West End Neighborhood Watch also suggest that we use the captains' suggestions of calling the non-emergency number to report suspicious activity and calling the school resource officer to report truancy. Increased reporting results in increased patrols. Captain Newnum stated the redrawing of beat boundaries happens every few years and would happen again soon.

Our reporting of incidents can help draw in the size of these beat boundaries, allowing officers to have a smaller area to patrol and helping increase consistent police presence in the neighborhood. We will be contacting the captains to meet with residents again in approximately 2 months time to see how the plan to increase police presence in the neighborhood is going.

The West End Association would like to thank Captains Lowder and Newnum for meeting with residents and City Council Member MacIntosh for helping us to organize this meeting. We would also like to thank all the neighbors who participated. It is with your continued interest and engagement that we will realize the goal of a West End that is safe for all.
