Historic Sea Products Carved Fish Sign

The well known carved wooden tarpon fish sign that points the way to **Sea Products** fish market on West End Blvd. was designated an Historic Sign by the Forsyth County Historic Resources Commission (HRC) at their March 6 meeting. The HRC is currently reviewing some older signs in Forsyth County to determine if they meet current zoning requirements. Historic Sign designation exempts a sign from meeting newer zoning requirements and prohibits changes to the sign without HRC staff approval. For a sign to be designated as "Historic" the HRC must find that a sign closely resembles its original appearance and is at least 25 years old. Applicants seeking historic designation must also show that the sign meets at least three of eight specific criteria listed on the HRC web page:

- *The sign bears a national or local emblem, logo, or other graphic that is unique to the property or the establishment, or that it is a remnant of an advertising program that is no longer used by the parent company.*
- *The sign is significant as reflecting the history of the building, structure, object, property or the development of the area, or recognized as important to the culture or history of Winston-Salem and Forsyth County.*
- *The sign possesses unique characteristic or incorporates materials, design, or craftsmanship not commonly found in newer signs.*
- *The sign is unique, notably aesthetic or creative, so as to make a significant contribution as a work of art.*
- *The sign is recognized as a popular focal point within the community.*
- *The sign is associated with historical individuals, events or places.*
- *The sign is characteristic of a specific historic period.*
- *The sign exhibits unique or rare characteristics that enhance the streetscape or the community at large.*

George personally carved the large tarpon from a thick piece of Poplar wood in 1998. It is mounted on a steel frame left by a previous business. The sign has guided customers to this popular fish-monger for the last 26 years and will continue to do so for years to come. It is now officially an Historic Sign. 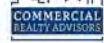
